# Notes to the Interim Statement of Financial Performance for the Period ended 31<sup>st</sup> December 2017

## 1. Introduction

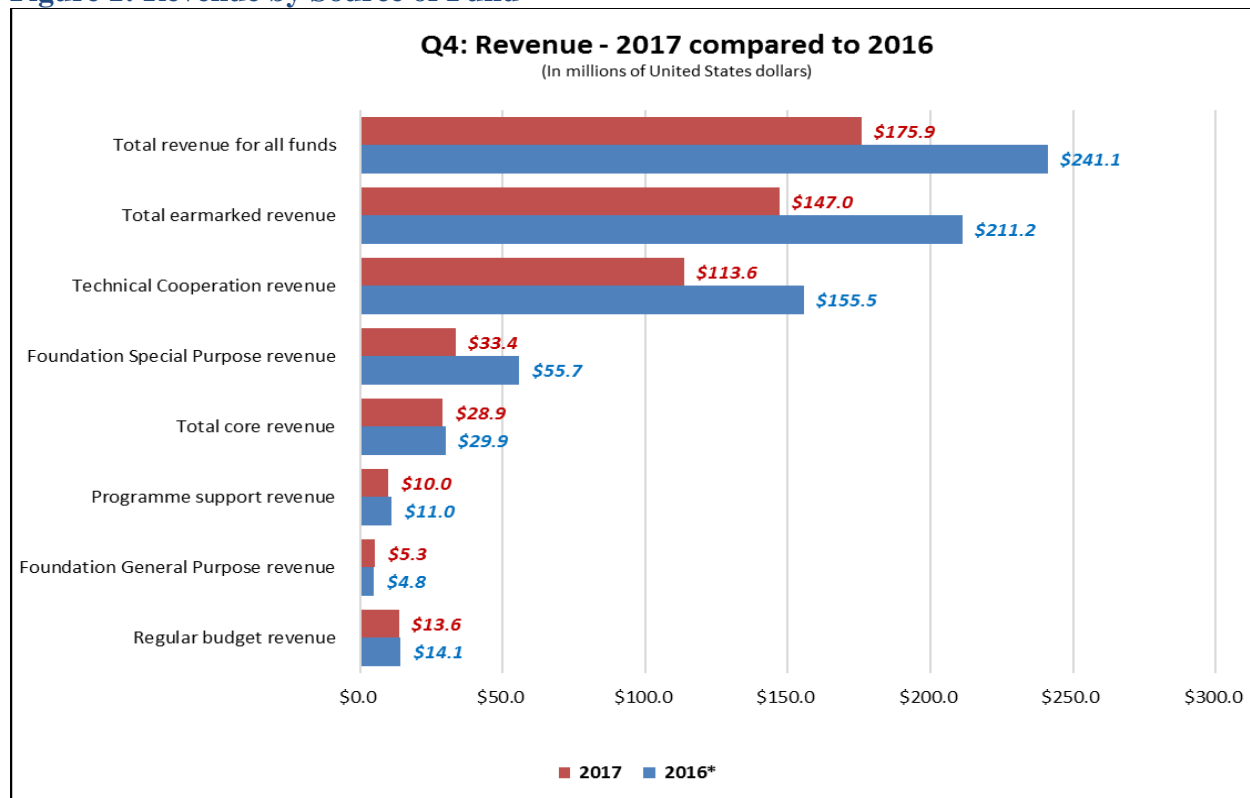
This financial status contained in the annexes is presented as at 31th December 2017 and provides an overview of UN-Habitat's interim financial performance for the period then ended. The statement is based on International Public-Sector Accounting Standards. A more complete presentation of the performance of UN-Habitat will be made in due course to the sub-committee on finance, based on the financial statement for 2018.

## 2. Aggregate Results

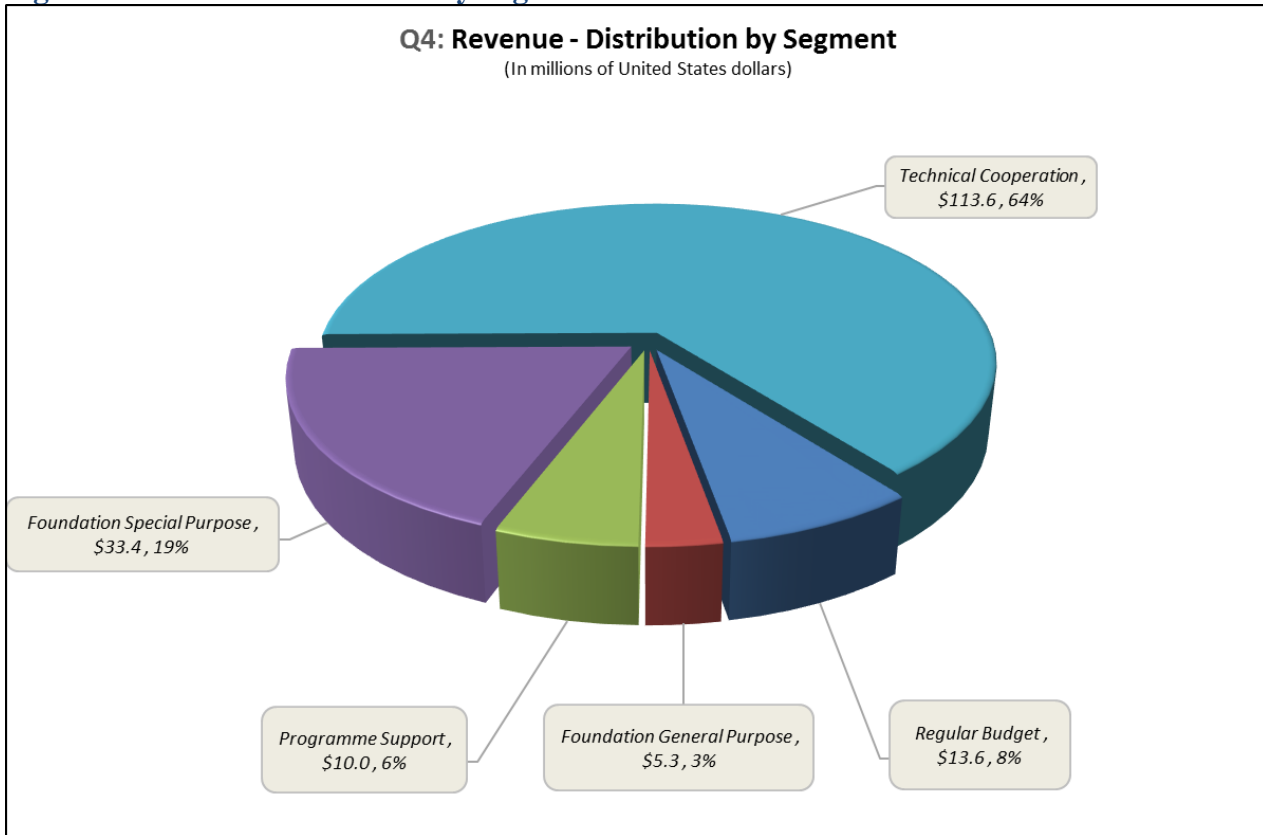
### 2.1. Revenue

Total revenue at the end of the fourth quarter, comprising of the regular budget, foundation general purpose, programme support, foundation special purpose and technical co-operation amounted to \$177.6 million (2016-Q4: \$241.1 million). Of this amount, \$28.9 million which is 16.3% was from core funds (2016-Q4: \$29.9 million) while \$148.7 million which is 83.7% was from earmarked resources (2016-Q4: \$211.2 million).

## 2.2. Expenditure

### 2.2.1. Budgeted expenditure

Total annual expenditure budget for the year 2017 amounted to \$241.5 million (Biennium: \$482.3 million) of which \$49.1 million which is 20.3% relates to core (Biennium: \$97.5 million) and \$192.4 million which is 79.7% relates to earmarked activities (Biennium: \$384.8 million).

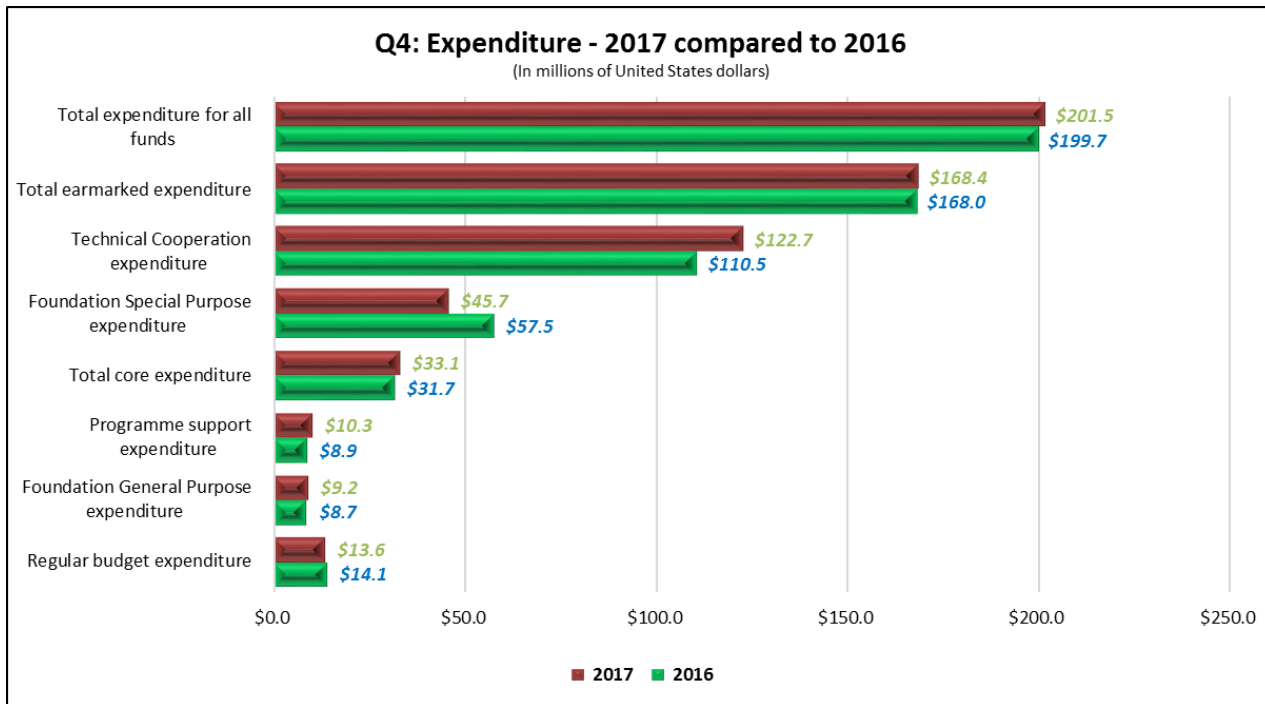
### 2.2.2. Allotted budgeted expenditure

Out of the total annual operating expenditure budget of \$241.5 million, a total of \$214.4 million was allotted and released representing 88.8%. This allotted amount represents \$34.9 million (16.3%) relating to core and \$179.5 million (83.7%) relating to earmarked activities.

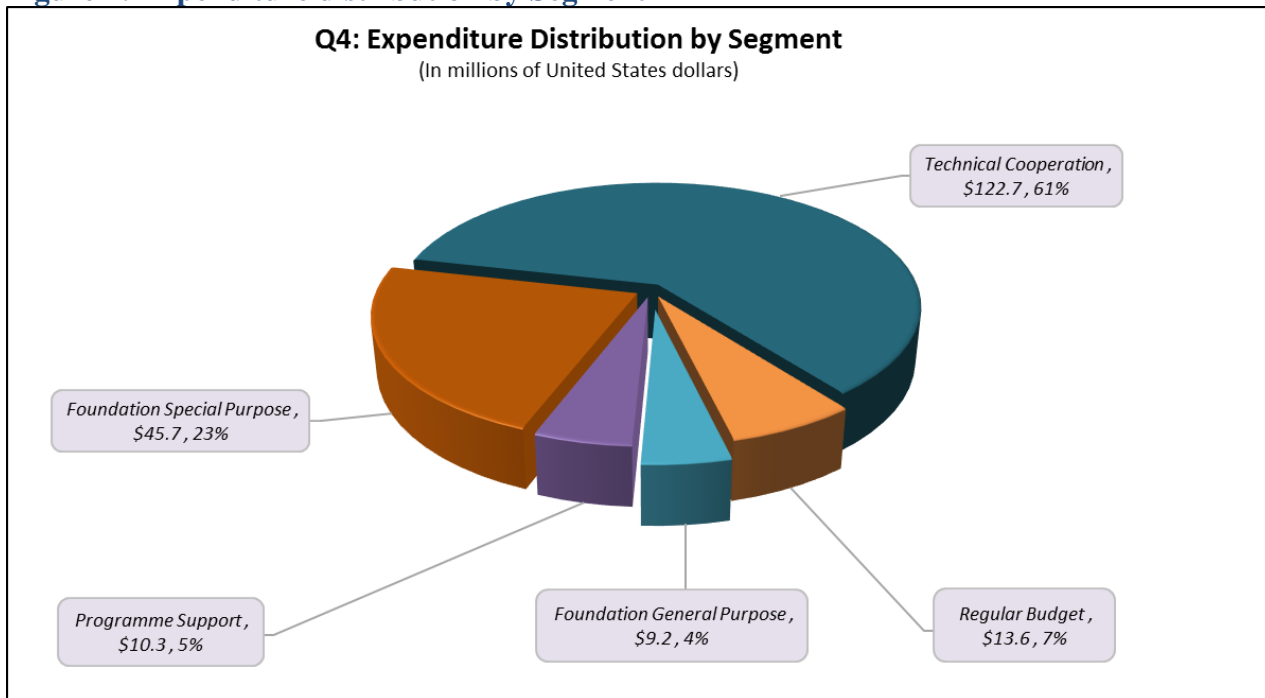
### 2.2.3. Actual expenditure

Total actual expenditure amounted to \$201.4 million (2016-Q4: \$199.7 million) of which \$33.1 million representing 16.4% is for core funds (2016-Q4: \$31.7 million) while \$168.3 million (83.6%) is for earmarked funds (2016-Q4: \$168.0 million). This represents about 83.4% execution rate on the WP&B annual budget and 93.9% on period allotted and released budget.

**Figure 4: Expenditure distribution by Segment**



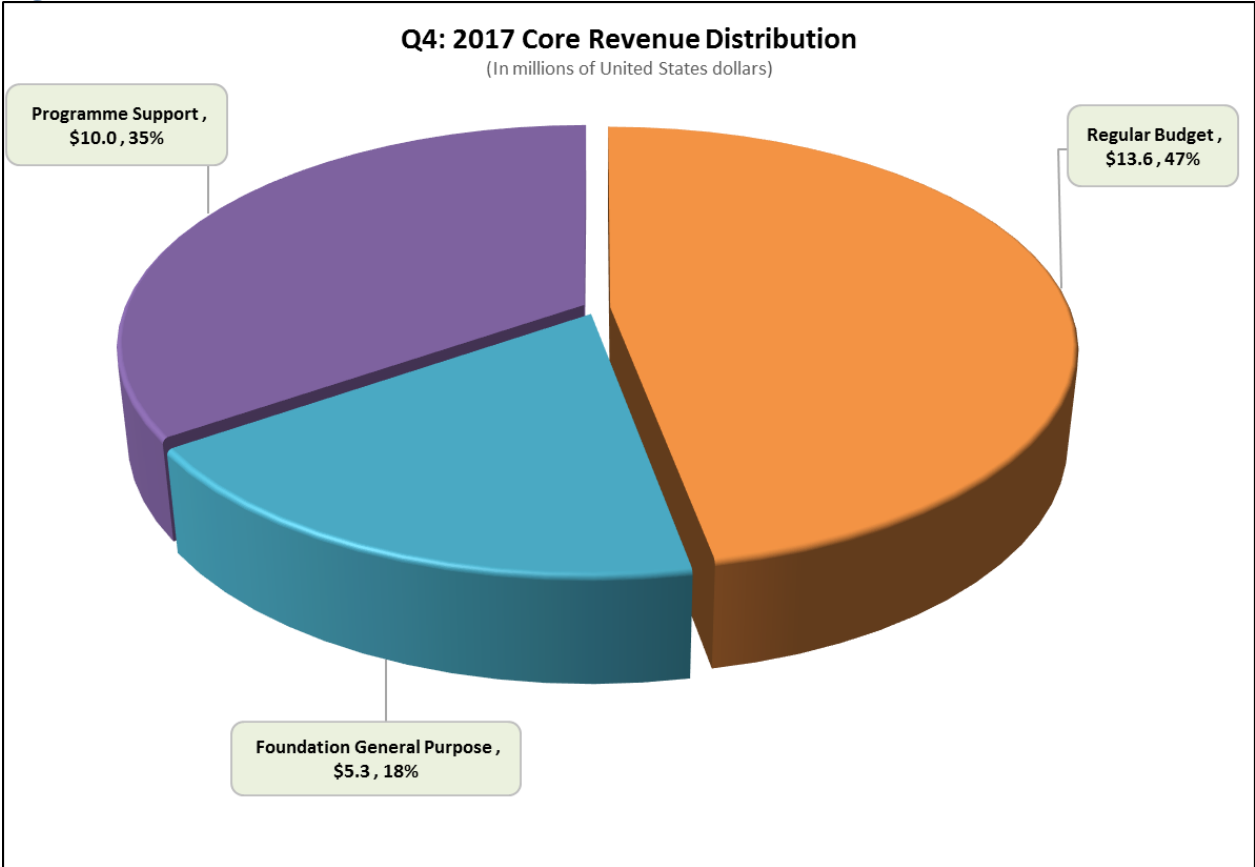
### 3. Performance of Core Funds

Core funds comprise of the regular budget, foundation general purpose and programme support. As at the reporting date, total core funds results were as follows:

#### 3.1. Revenue

Total core revenue, comprising of the regular budget, foundation general purpose and programme support amounted to \$28.9 million. Regular budget amounted to \$13.6 million, foundation general purpose amounted to \$5.3 million (of which Voluntary Contributions amounted to \$2.6 million) while programme support accounted for \$10.0 million.

**3.2. Budgeted core expenditure**

Total budgeted core operating expenditure for the year amounted to \$49.1 million. This comprised of \$11.6 million of regular budget (23.6%), \$22.8 million foundation general purpose (46.4%) and USD 14.7 million programme support (30.0%).

**3.3. Allotted core expenditure budget**

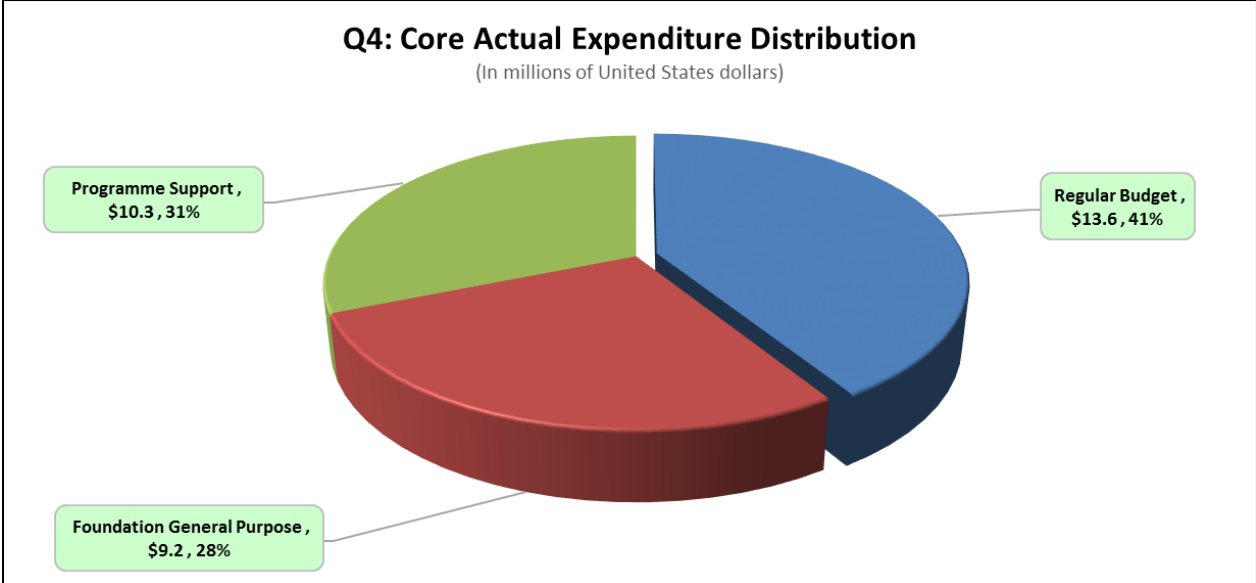
Of the allotted core budget of \$34.9 million, \$12.9 million (37.0%) represented regular budget, \$9.6 million (27.5%) represented foundation general purpose while \$12.4 million (35.5%) was for programme support.

**3.4. Actual core expenditure:**

Total actual core expenditure amounted to \$33.1 million which was 94.8% of the allotted core amount and 67.4% of the annual WP&B annual budget. Regular budget expenditure of \$13.6 million represents about 105.4% of allotted amount and 117.2% of annual budget. The amount represents 41.1.6% of total core expenditure. Foundation general purpose expenditure of \$9.2 million is 95.8% of allotment and 40.4% of the

annual budget. This represents 27.8% of total core expenditure. Expenditure of \$10.3 million on programme support is 83.1% of allotted amount and 70.1% of the annual budget. This represents 31.1% of total core expenditure.

**Figure 6: Core Expenditure Distribution**



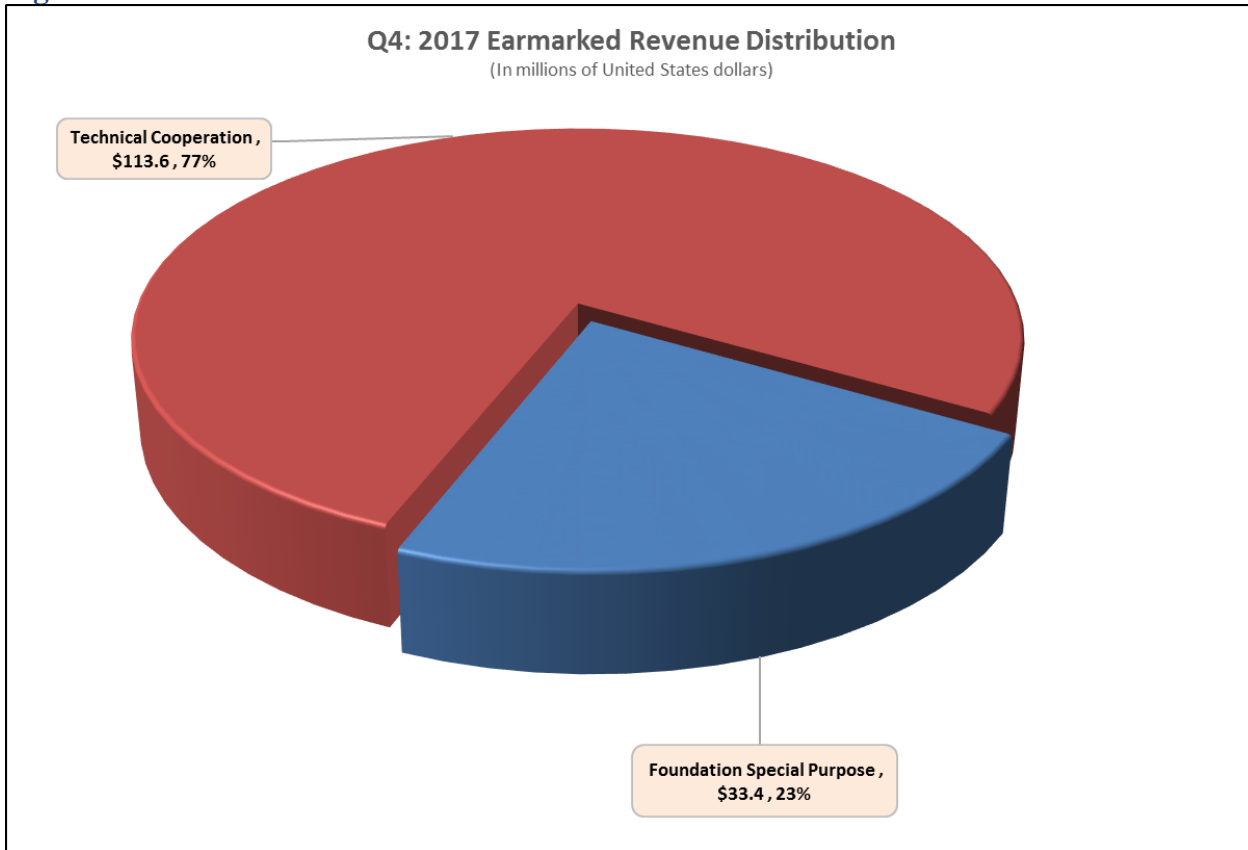
## 4. Performance of Ear-marked Funds

Ear-marked funds comprise of the foundation special purpose fund and technical cooperation fund. As at the reporting date, total earmarked funds results were as follows:

### 4.1. Revenue

Total ear-marked revenue, comprising of the foundation special purpose and technical co-operation amounted to \$147.0 million. Foundation special purpose amounted to \$33.4 million which is 22.7% of total earmarked revenue while technical cooperation accounted for \$113.6 million which is 77.3% of total earmarked revenue.

**4.2. Budgeted Ear-marked expenditure**

Total budgeted earmarked operating expenditure for the reporting period amounted to \$192.4 million. This comprised of \$45.2 million (23.5%) of foundation special purpose budget and \$147.2 million (76.5%) of technical cooperation budget.

**4.3. Allotted ear-marked expenditure budget:**

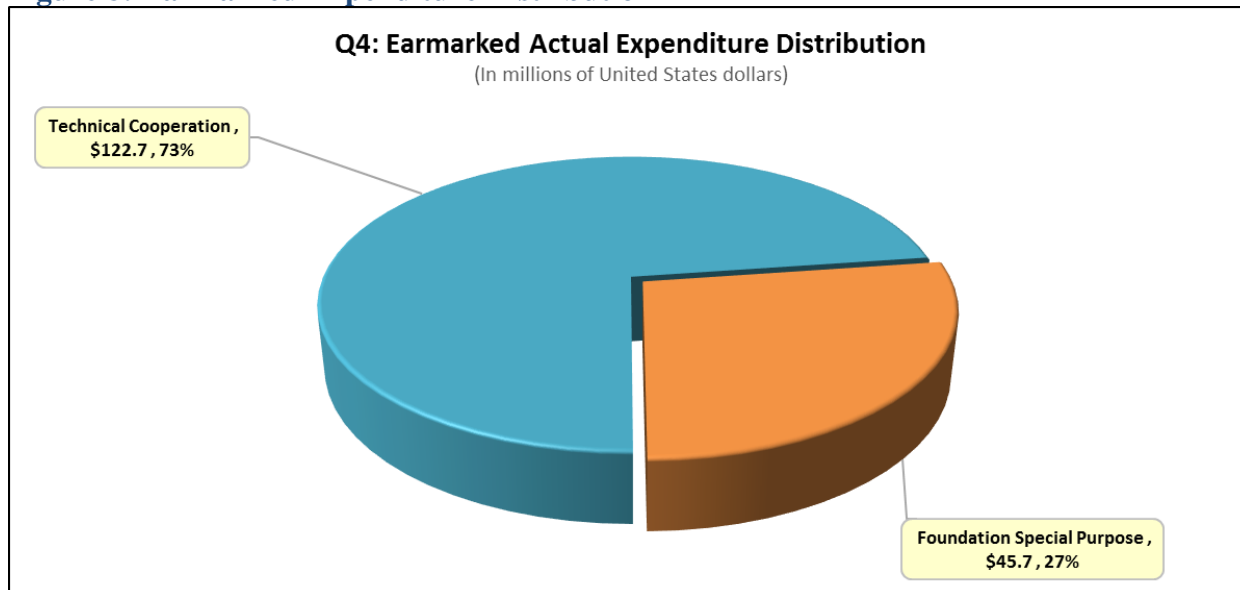
Of the allotted budget of \$179.4 million, \$41.1 million (22.9%) represented foundation special purpose while \$138.3 million (77.1%) was for technical cooperation.

**4.4. Actual earmarked expenditure:**

Total actual ear-marked expenditure for the period amounted to \$168.4 million which was 93.9% of the allotted budget and 87.5% of the annual budget. Foundation special purpose expenditure of \$45.7 million represents 27.1% of total ear-marked expenditure and is 111.2% allotted budget execution and about 101.1% of the annual budget. Expenditure of \$122.7 million on technical cooperation is 72.9% of total ear-marked expenditure and represents an 88.7% allotted budget execution rate and 83.4% of the annual budget.

## 5. Fund balances and reserves

### 5.1. Core Funds

Total Core fund balances and reserves at the start of the year amounted to \$21.8 million with \$6.1 million (28.0%) in the Foundation General Purpose account and \$15.7 million (72.0%) in the Programme Support account. The funds included mandatory reserves of \$4.6 million and \$2.9 million respectively. Total core fund balances at the end of the reporting period amounted to \$17.6 million representing \$2.6 million for the Foundation General Purpose account and \$15.0 million for Programme Support account, inclusive of the mandatory reserves. No fund balances are realised for regular budget.

#### 5.1.1. Foundation general purpose fund balances

The total fund balances of \$2.6 million represent the mandatory general reserve of \$2.6 million, a reduction from \$4.6 million following Governing Council resolution. An inter-fund transfer of \$0.4 million was made from Programme Support account to regularize the fund balance in line with the Executive Director's authority on administration of Programme Support revenue. An additional inter-fund transfer of This means that the spendable portion of fund balances was depleted at the end of the year.

#### 5.1.2. Programme support fund balances

The Programme support fund balances of \$15.0 million include a mandatory reserve of \$2.9 million. An inter-fund transfer of \$0.4 million was made to the Foundation General Purpose account. Spendable fund balances available at the end of the period amount to \$12.0 million. At the current rate of expenditure and commitments, these reserves are adequate to cover one year of operations in the event there is a decline in the inflow of Programme support revenue. This is an adverse situation considering that Programme Support has also been called to bail out the troubled Foundation General Purpose.

## **5.2. Ear-marked Funds:**

Total ear-marked fund balances and reserves at the start of the year stood at \$372.2 million represented by \$109.0 million (29.3%) in the Foundation Special Purpose and \$263.2 million (70.7%) in the Technical Cooperation account inclusive of reserves of \$4.0 million and \$11.4 million respectively. Fund balances at the end of the reporting period amounted to \$350.9 million representing \$96.8 million and \$254.1 million for the Foundation Special Purpose Technical Cooperation respectively inclusive of reserves.

### **5.2.1. Foundation special purpose fund balances**

The Foundation Special Purpose fund balances of \$96.8 million include a reserve of \$4.0 million. This means that spendable fund balances available at the end of the period amount to \$92.8 million.

### **5.2.2. Technical cooperation fund balances**

The Technical cooperation fund balances of \$254.1 million include a reserve of \$11.4 million. This implies that spendable fund balances available at the end of the reporting period amount to \$242.7 million.

## **6. Conclusion**

A summary of the revenue, expenses, fund balances and reserves is provided in Annex A, while the comparison of actuals and budget is shown in Annex B. Details of non-earmarked and earmarked contributions are given in Annexes C to F.

The financial position of the Foundation General Purpose reached the lowest point at the end of the period and is in dire need of a cash injection. Across the core budget, UN-Habitat is likely to incur a deficit of \$4.2 million for 2017, which has further depleted fund balances. In order to resolve a situation which has been unsustainable for some years, there is an urgent need for a Member State decision to address the financial challenges faced by the Foundation General Purpose fund and core budget as a whole if basic mandated operations are to continue in 2018 and beyond.

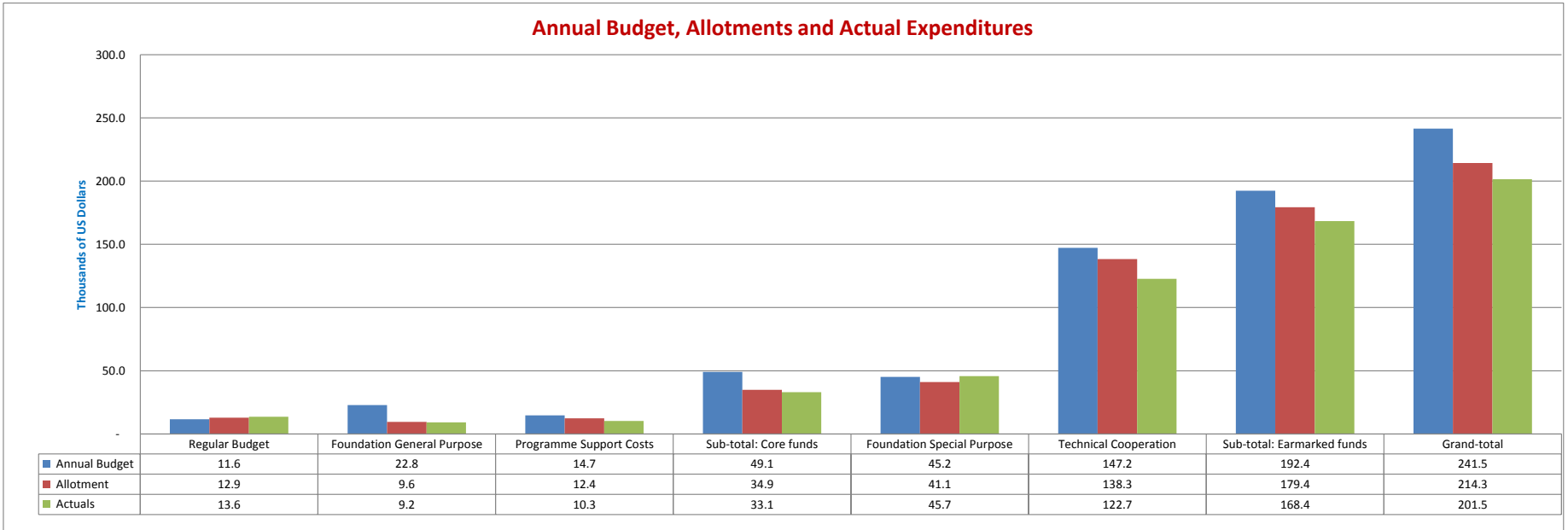
