All documents to be reviewed **MUST** be sent to the PAG Secretary **10 days in advance** of the PAG meeting. This allows the PAG secretary to review and have any revisions done by the Project Leader before the document is finally sent out to PAG reviewers, in compliance with the 7 day policy in advance PAG.

Documents coming from the Regional PAGs to peer reviewers (Branches and cross-cutting issues) at HQ must respect the rule of circulating documents 7 days in advance of PAG. This is to allow reviewer ample time for reflection on content and comments.
